Important Instructions

1. All life members of the Indian Society of Citriculture (ISC) having a continuous standing for five years or more, and also have made substantial contributions in the fields of either research or development in citriculture or industry are eligible to be considered for the FELLOWSHIP of the Society.
2. For in-service personnel, self-nomination is permitted subject to certification (Sl. No. I-1 in the application proforma) by the competent authority of the applicant. Application without certification by the competent authority shall not be considered. However, candidates holding RMP positions (e.g. Director or above) may send their application directly, subject to the nomination by any ISC member (Sl. No. I-2 in the application proforma).
3. For retired or self-employed personnel, the nominations can be made by any member of ISC and seconded by another ISC member (Sl. No. I-2 in the application proforma). Application without signature of the PROPOSER and SECONDER shall not be considered.
4. One ISC member can nominate maximum five and second maximum seven applicants. However, executive committee members of ISC are not eligible to nominate any applicant.
5. The number of FELLOWS admitted each year shall be decided by the EXECUTIVE COUNCIL of ISC but restricted to maximum 3 fellows per year subject to the fulfillment of mentioned criteria. **There will be no application fees.**
6. All entries in the Nomination Form (Sl. No. A-1 to G) should be typewritten.
7. Documentary proofs for all claims made (Sl. No. B-1 to E) must be attached. Score will not be awarded if claims made without any documentary proof. All documentary proof should be arranged in the same order of claims made followed by numbering on the upper right corner of each page.
8. Duly completed Application Proforma should be sent by Registered Post / Courier / Speed post or by Hand, to **The President, Indian Society of Citriculture, ICAR-Central Citrus Research Institute, Amravati Road, Nagpur – 440033, Maharashtra, India** so as to reach by **3rd October, 2023**. To avoid postal delay, scanned copy of complete application proforma along with documentary proofs (as single PDF file) should be sent

by email to iscccri@gmail.com before **3rd October, 2023**. The ISC will not be held responsible for non-receipt of application proforma (hard copy or soft copy) before above-mentioned deadline.

9. Applicants must secure minimum 50 score for further screening by expert committee.
10. **“Application for ISC Fellowship”** should be written **on the envelope** containing the application proforma or **in the subject line of the email**.
