Guidelines to Authors

The manuscript must be type-written in MS Word format (Page size A4, Margine: 1 inch/2.54 cm from all sides).

1. **Title:** The manuscript title should be concise, specific and informative. Avoid abbreviations and formulae wherever possible. Times New Roman Font, 14 pt size, Bold, Sentence case, Double spaced, Centre alignment.
2. **Author(s) name:** All authors of a manuscript should write their full name (Given name followed by Family name) and check that all names are accurately spelled. For multi-institutional team of authors, the names and respective addresses of all co-authors should be suffixed with superscript numerals. Times New Roman Font, 12 pt size, Bold, Uppercase/All caps, Double spaced, Centre alignment.
3. **Affiliation:** Complete address of the institution(s) should be given to all author(s) in the same order of list of authors. The respective address of co-authors should be prefixed with superscript numerals. Times New Roman Font, 10 pt size, Italics, Sentence case, Double spaced, Centre alignment. If the address of any author(s) is changed during the peer review process, the updated address should be given in the revised manuscript.
4. **Corresponding author:** The name of the corresponding author should be suffixed with an Asterisk (*). The corresponding author will handle correspondence at all stages of refereeing and publication, also post-publication. This responsibility also includes answering any future queries about the manuscript. The active email id and mobile number of the corresponding author should be given at the end of the addresses. Ensure that the e-mail address and mobile number given are kept active by the corresponding author.
5. **Abstract:** A concise and factual abstract must be given after the title page. The body of the abstract (Times New Roman Font, 10 pt size, Italics, Sentence case, Double spaced, Justify alignment) should state briefly the purpose of the research, the principal results and major conclusions (not exceeding 150 words). An abstract is often presented separately from the article, so it must be able to stand alone. Also, non-standard or uncommon abbreviations should be avoided, but if essential they must be defined at their first mention in the abstract itself.
6. **Main text:** The main text should be written in Times New Roman Font, 11 pt size, Sentence case, Double spaced, Justify alignment. Authors can use headings (Times New Roman Font, 11 pt size, Bold, Sentence case, Double spaced, Justify alignment), sub-headings (Times New Roman Font, 11 pt size, Bold, Italics, Sentence case, Double spaced, Justify alignment), and sub-sub-headings (Times New Roman Font, 10 pt size, Italics, Sentence case, Double spaced, Justify alignment), if required. Please do not number the headings and sub-headings until it is necessary.
7. **Tables:** Each table should be typed in Microsoft-Word Table format and should be placed at the relevant place in the manuscript. Number tables consecutively in accordance with their appearance in the text and place table notes, if any (for describing the abbreviation,

alphabetical notations, etc. used in the table) below the table body. Be sparing in the use of tables and ensure that the data presented in them do not duplicate results described elsewhere in the article or in the figures. Construct the table in such a way so that it should not occupy much space and can be easily understandable by the readers. Avoid shading table cells. Each table should contain a self-explanatory heading (e.g. Table 1: Effect of different treatments on growth and yield of acid lime). The heading should be written in Times New Roman Font, 10 pt size, Bold, Sentence case, Double spaced, Justify alignment.

8. Figures: Each figure should be placed at the relevant place in the manuscript. Separately provide the figures either in JPEG or TIFF format (minimum of 300 dpi resolution) during submission. Number the figures consecutively in accordance with their appearance in the text. The standard format of graphs should preferably be used and legends (if any) should be given. Similar to tables, ensure that each figure has a suitable caption. The caption should comprise a brief title (not on the figure itself) and a description of the illustration. Explain all symbols and abbreviations used (if any) after the title. Symbols and lettering size will be 10 point in Times New Roman. Overlapping of the symbols and data should be avoided. Avoid variations in font size in a single figure. If more than one figures are grouped into a single figure, each sub-figure should be sequentially marked with alphabets as (a), (b), (c)... and described in the figure caption. The figure caption should be written in Times New Roman Font, 10 pt size, Bold, Sentence case, Double spaced, Justify alignment. The artwork (e.g. image, graphics) should be of a minimum of 300 dpi resolution. Please do not use any artwork which is optimized for screen use (e.g. GIF, BMP, WPG, etc.) and of low resolution. All maps/satellite images should have a measure of scale (scale bar), north arrow (directional grid), and a legend and all print should be legible after 1/4th size reduction.

9. Citation in text, tables and figures: All citations should refer to:

- Single author: The author's family name (without initials unless there is ambiguity) and the year of publication [e.g.reported by Mitra (2007) orwith earlier work (Mitra, 2007)].
- Two authors: Both authors' family names and the year of publication [e.g.reported by Singh and Kumar (2011) orwith earlier work (Singh and Kumar, 2011)].
- Three or more authors: first author's family name followed by 'et al.' and the year of publication [e.g.reported by Pihur et al. (2008) orwith earlier work (Pihur et al., 2008)].
- More than one reference from the same author(s) in the same year must be identified by the letters 'a', 'b', 'c', etc., placed after the year of publication [e.g. Sundaram (2015a and 2015b)].
- Groups of references can be listed either first chronologically, and then alphabetically [e.g. ...reported by previous workers (Joshi 2001a, 2001b; Sharma and Ali, 2003; Manikandan et al., 2003) or ...as demonstrated by Joshi (2001a and 2001b), Sharma and Ali (2003) and Manikandan et al. (2003)].

10. Reference list: Please ensure that every reference cited in the text is also present in the reference list (and vice versa). All references should be written in Times New Roman Font, 10 pt size, Double spaced, Justify alignment, 0.25 inch hanging indentation. Unpublished results are not recommended in the reference list as well as in the text. An article should not be referred to as 'in press'. The reference should be cited in alphabetical order and should not be numbered. For web references, as a minimum, the full URL should be given and mention the date when the website was last accessed. Any further information, if available (e.g. DOI, author names, dates, reference to a source publication, etc.), may also be given. The journal name should not be given in abbreviated form.

11. Authors' Information: Please mention the name, complete affiliation and color photographs of all authors in following tabular format. Write the name and affiliation of the author in Times New Roman Font, 10 pt size, Bold, Double spaced, Justify alignment. Separately provide the individual photographs of all authors either in JPEG or TIFF format (minimum of 300 dpi resolution) during submission.

12. List of Abbreviation (Optional): If any abbreviations (other than standard abbreviations) or short name of chemicals/ formulations, etc. are used in the article, the author(s) should provide a list of all such abbreviations along with their expanded form to facilitate the reviewers and readers. All such non-standard abbreviations must be defined at their first mention in the article itself. The list of abbreviation should be written in Times New Roman Font, 10 pt size, Sentence case, Double spaced, Left alignment.

13. Acknowledgement (Optional): If any, a brief acknowledgement may be given. The acknowledgement should recognize the physical support, funding support, administrative help, analytical service, technical guidance, etc. received by the authors. The body of the acknowledgement should be written in Times New Roman Font, 10 pt size, Sentence case, Double spaced, Justify alignment.

14. Disclosure Statements: The corresponding authors, on behalf of all authors, mandatorily disclose the following statement. The statement should be written in Times New Roman Font, 10 pt size, Sentence case, Double spaced, Justify alignment.

“The author(s) declare(s) no known conflict of interests that could have appeared to influence the work reported in this paper. All authors read, reviewed, agreed, and approved the final manuscript. The manuscript has not been submitted to any other journal/magazine for publication.”

15. Submission and future correspondence: The corresponding authors should submit the article (MS Word file) along with images (in jpeg or tiff format) to the Chief Editor by email (emagazine@icindia.org.in with a copy to iscccri@gmail.com). After submission, all correspondence (e.g. revision, acceptance, rejection, published copy, etc.) will be sent to the corresponding author by email.
